ABOUT EGTS

Eastern Gas Transmission and Storage, Inc. (EGTS), a BHE GT&S company, provides safe, reliable and affordable natural gas transportation and storage services to markets in Maryland, New York, Ohio, Pennsylvania, Virginia and West Virginia. EGTS safely operates nearly 4,000 miles of pipeline and more than 985,000 horsepower of compression, offering one of the largest underground natural gas storage systems in the United States. It links to other major pipeline markets in the Midwest, Mid-Atlantic and Northeast regions, and provides reliable energy for a number of large customers, including utilities and power plants, as well as local distribution companies to heat homes and run small businesses.

PROJECT OVERVIEW

EGTS proposed Project Stratum to meet the growing energy needs of customers across Pennsylvania. Project Stratum will leverage existing EGTS infrastructure while increasing the capacity on its system through pipeline additions and station upgrades. This will create 250,000 dekatherms/day of firm transportation capacity from receipt points at Tioga County, PA for deliveries to Beaver County, PA and Clinton County, PA.

Regulatory approval for the project will be obtained via application to the Federal Energy Regulatory Commission (FERC) pursuant to Section 7(c) of the Natural Gas Act.

EGTS is committed to safety and environmental respect for the benefit of communities and its employees. EGTS maintains operating policies and procedures that adhere to United States Department of Transportation (USDOT) safety requirements for inspections, testing, operations, preventive maintenance, repairs, vigilant patrols of facilities and more.

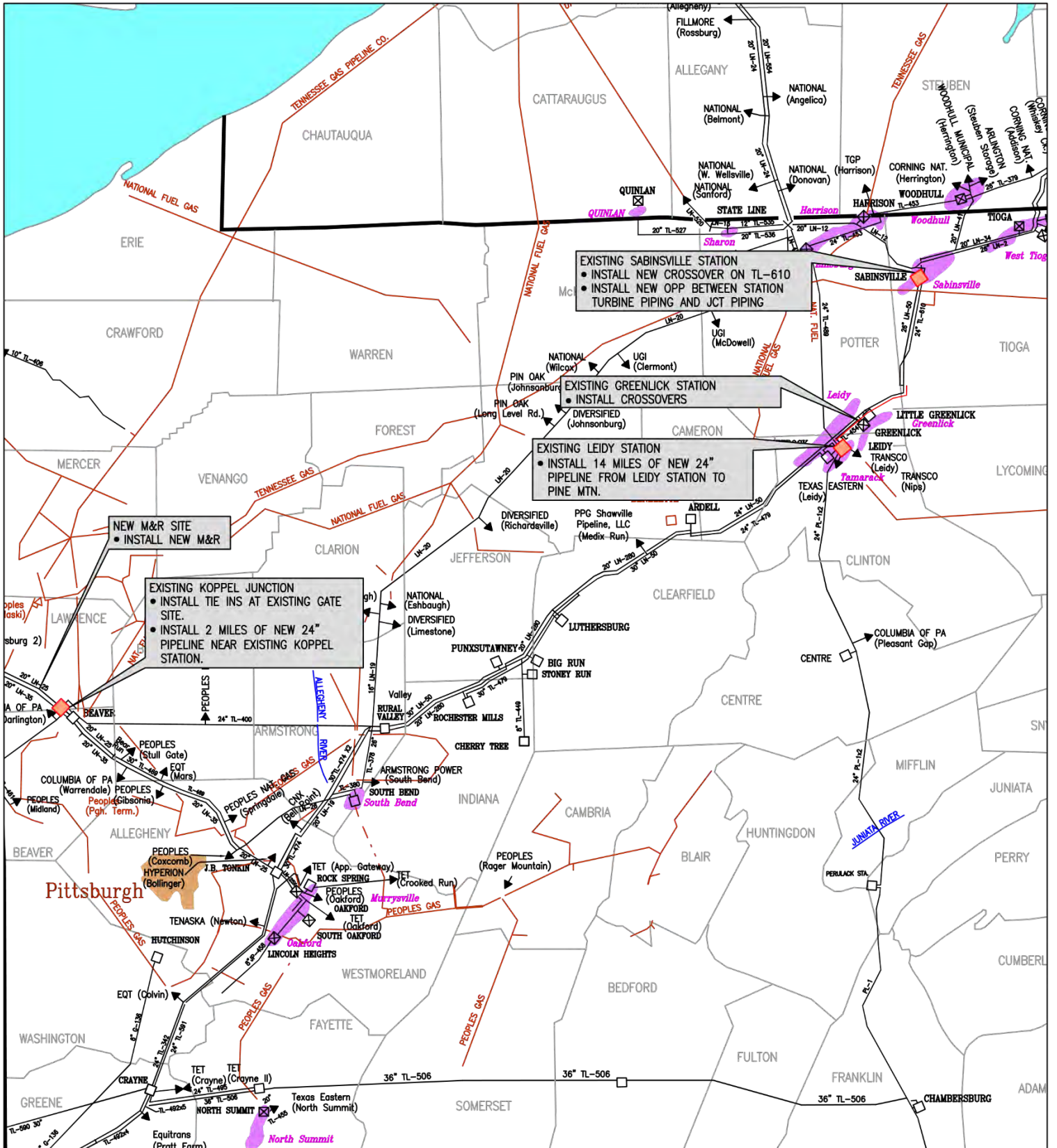
PROJECT DETAILS

The project includes the installation and upgrade of infrastructure in Pennsylvania. Key components include:

- Clinton County, PA and Potter County, PA - Leidy Station to Pine Mountain**
 - ✓ Complete installation of 14 miles of 24" pipeline
- Beaver County, PA - Koppel Junction**
 - ✓ Complete installation of 2 miles of 24" pipeline
- Tioga County, PA - Sabinsville Station**
 - ✓ Install full-size discharge crossover piping
 - ✓ Upgrades to existing facilities
- Lawrence County, PA - New M&R Station**
 - ✓ Complete construction of new measurement and regulation station
- Potter County, PA - Greenlick Station**
 - ✓ Install crossover piping
